

At the Council meeting held Wednesday, May 15, 2024, at 5:00 P.M., in the Hibbing City Council Chambers, Councilor Chris Whitney offered the following resolution and moved its adoption:

**RESOLUTION No. 24-05-04**

RESOLUTION MODIFYING CALENDAR PARKING  
WITHIN THE CITY OF HIBBING AFTER A PUBLIC HEARING

WHEREAS, after due and proper published notice of hearing, a public hearing was duly held at the Council Chambers, City Hall, 401 East 21st Street, City of Hibbing, State of Minnesota, at 5:00 P.M. on Wednesday, May 15, 2024, at which time it was determined that it is in the best interest of the public to implement calendar parking in the City of Hibbing EXCEPT for the following streets and avenues year around:

- Kitzville
- All areas South and East of Highway 169
- 9th Avenue West from 37th Street to Highway 169
- 37th Street from Highway 169 to 9th Avenue West
- 2nd Avenue West from Howard Street south to 37th Street
- 1st Avenue from 19th Street south to Highway 169
- 7th Avenue East from 19th Street south to 37th Street
- 31st Street from 7th Avenue East west to 5th Avenue West
- 1st Avenue East from 37th Street north to 31st Street
- 3rd Avenue East from 13th Street south to 31st Street
- 25th Street from Brooklyn Drive west to 2nd Avenue West
- 9th Avenue East from Howard Street south to 25th Street
- 11th Avenue East from Howard Street south to 25th Street
- Brooklyn Drive and 12th Avenue East from 19th Street to 25th Street
- 23rd Street from Brooklyn Drive west to 2nd Avenue West
- 21st Street from 12th Avenue East to 11th Avenue East and 9th Avenue East west to 1st Avenue
- Howard Street from 12th Avenue East west to 2nd Avenue West
- 19th Street from 12th Avenue East to 7th Avenue East
- 13th Street from Highway 169 west to 3rd Avenue East
- 5th Avenue West from Howard Street south to 31st Street
- All areas west of 9th Avenue West (Kerr/Leetonia/Kelly Lake)

and to establish the following "NO PARKING" areas:

- No Parking at any time on 19th Street from 1st Avenue to 5th Avenue East

NOW, THEREFORE, The City Council of the City of Hibbing hereby resolves as follows:

1. Calendar parking in the City of Hibbing is implemented EXCEPT for the following streets and avenues year around:
  - Kitzville
  - All areas South and East of Highway 169
  - 9th Avenue West from 37th Street to Highway 169
  - 37th Street from Highway 169 to 9th Avenue West
  - 2nd Avenue West from Howard Street south to 37th Street
  - 1st Avenue from 19th Street south to Highway 169
  - 7th Avenue East from 19th Street south to 37th Street
  - 31st Street from 7th Avenue East west to 5th Avenue West
  - 1st Avenue East from 37th Street north to 31st Street
  - 3rd Avenue East from 13th Street south to 31st Street
  - 25th Street from Brooklyn Drive west to 2nd Avenue West
  - 9th Avenue East from Howard Street south to 25th Street
  - 11th Avenue East from Howard Street south to 25th Street
  - Brooklyn Drive and 12th Avenue East from 19th Street to 25th Street
  - 23rd Street from Brooklyn Drive west to 2nd Avenue West
  - 21st Street from 12th Avenue East to 11th Avenue East and 9th Avenue East west to 1st Avenue
  - Howard Street from 12th Avenue East west to 2nd Avenue West
  - 19th Street from 12th Avenue East to 7th Avenue East
  - 13th Street from Highway 169 west to 3rd Avenue East
  - 5th Avenue West from Howard Street south to 31st Street
  - All areas west of 9th Avenue West (Kerr/Leetonia/Kelly Lake)
2. The following "NO PARKING" areas are established:
  - No Parking at any time on 19th Street from 1st Avenue to 5th Avenue East
3. Appropriate signage shall be erected or removed to notify the public of the parking regulations.
4. That calendar parking will not be enforced on a street or avenue under construction.


