

ORDINANCE NO. 441, 2ND SERIES

AN ORDINANCE OF THE CITY OF HIBBING, MINNESOTA, AMENDING HIBBING CITY CODE CHAPTER 10 ENTITLED "PUBLIC PROTECTION, CRIMES AND OFFENSES", BY AMENDING SECTION 10.05 ENTITLED 'FEEDING OF PIGEONS'; AND, BY ADOPTING BY REFERENCE, HIBBING CITY CODE CHAPTER 1 AND SECTION 10.99 WHICH, AMONG OTHER THINGS, CONTAIN PENALTY PROVISIONS.

THE CITY COUNCIL OF HIBBING, MINNESOTA ORDAINS:

Section 1. Hibbing City Code, Section 10.05, entitled "Feeding of Pigeons" is hereby deleted in its entirety and there is hereby added a new Section 10.05, entitled "Feeding of Pigeons, Migratory Waterfowl and Animals", to read as follows:

"Sec. 10.05 FEEDING OF PIGEONS, MIGRATORY WATERFOWL AND WILD ANIMALS.

A. The feeding of pigeons and non-domesticated migratory waterfowl (ducks and geese) is prohibited except for pigeon control programs contracted for by the City Council. No person shall feed a non-domesticated pigeon or migratory waterfowl nor place feed in a place or manner that a reasonable person would expect to result in feeding a non-domesticated pigeon or migratory waterfowl. This Section does not apply to domesticated pigeons such as those kept for racing, entertainment performances or agricultural purposes.

B. The feeding of wild animals defined as bears, deer, coyotes, and wolves is prohibited. No person shall feed bears, deer, coyotes, or wolves nor place feed in a place and or manner that a reasonable person would expect to result in feeding a wild animal as defined above.

C. That the prohibitions set forth in A and B are limited to the urban service district of the City of Hibbing.

D. A violation of this Section 10.05 shall be a minimum fine of \$100.00."

Section 2. Penalties. Hibbing City Code Chapter 1 entitled "General Provisions and Definitions Applicable to the Entire City Code Including Penalty for Violation" and Section 10.99 entitled "Violations a Misdemeanor" are hereby adopted in their entirety, by reference, as though repeated verbatim herein.

Section 3. After adoption, signing and attestation, this ordinance shall be published once in the official newspaper of the City and shall be in effect on and after the date following such publication.
