In consideration of the issuance of a permit, applicant agrees:

1. To obtain an excavation permit prior to excavation on City property.
2. To pay in advance to the City Clerk an amount equal to the estimated costs as determined by the City Engineer which costs shall include estimated cost of repair, such as back-filling, compacting, resurfacing and replacement, and shall also include cost of permanent and temporary repairs due to weather or other conditions and the cost of such investigation by the City Engineer.
3. In lieu of payment, in advance of all of the costs set forth in the previous sentence, the applicant agrees to furnish an annual payment and performance bond which shall be the greater of \$10,000.00 or the amount of all of the estimated costs and investigation computed in accordance with the previous sentence for all work to be done by said applicant within the twelve month period commencing with the date of said bond.
4. To provide such barricades and flashers as are necessary to protect the public, as may be required by appropriate City officials, and to notify the City Fire Department if any street, alley or thoroughfare shall be blocked.
5. To properly compact backfill in 6-inch layers with sand or gravel, and immediately upon completion of the work below grade, to restore the grade to the same condition as it was immediately prior to the excavation, so as to complete such restoration within _____ days after excavation, with all work to be done in accordance with applicable City Ordinances and requirements of appropriate city officials.
6. To hold the City harmless from any and all liability, including the cost of defense thereof which may arise in connection with the work to be done as herein above set forth.
7. To guarantee the above repair work and restoration for a period of one year from date of completion of repair and restoration, and upon request by appropriate City officials immediately repair and restore the same should such work become unsatisfactory within the one year guarantee period.
8. To pay all actual costs of repair over and above the amount estimated by the City Engineer including the cost of such investigation, to be made within thirty (30) days following completion of permanent repairs.
