

## ORDINANCE NO. 449, 2ND SERIES

AN ORDINANCE OF THE CITY OF HIBBING, MINNESOTA, AMENDING HIBBING CITY CODE CHAPTER 6 ENTITLED "OTHER BUSINESS REGULATION AND LICENSING", BY AMENDING SECTION 6.28 ENTITLED 'TAXICABS'; AND, BY ADOPTING BY REFERENCE, HIBBING CITY CODE CHAPTER 1 AND SECTION 6.99 WHICH, AMONG OTHER THINGS, CONTAIN PENALTY PROVISIONS.

THE CITY COUNCIL OF HIBBING, MINNESOTA ORDAINS:

**Section 1.** There shall be added a new subparagraph 8 to paragraph E "Prerequisites to license" of Subd. 2 entitled "Taxicab driver's license" of Section 6.28 "Taxicabs", to read as follows:

Section 6.28 Taxicabs  
Subd. 2 Taxicab Driver's License  
E. Prerequisites to License

"8. Along with the form from the City, the Applicant must provide a site plan as to where any off street parking shall take place with respect to said business. Said site plan shall also be provided to the Building Official who shall approve said site plan before an Applicant's application will be submitted to the City of Council.

- a. It is specifically recognized that no taxicab license shall have more than four (4) vehicles on the premises whether they be cabs, owners' private vehicles or employee's personal vehicles at any one time when said taxicab business is located out of a residential property within the City's urban district. That no more than six (6) vehicles may be on the premises if said taxicab business is located within the City but outside the City's urban district. None of the vehicles of the owner or its employees may be on the street."

**Section 2.** Penalties. Hibbing City Code Chapter 1 entitled "General Provisions and Definitions Applicable to the Entire City Code Including Penalty for Violation" and Section 6.99 entitled "Violations a Misdemeanor" are hereby adopted in their entirety, by reference, as though repeated verbatim herein.

**Section 3.** After adoption, signing and attestation, this ordinance shall be published once in the official newspaper of the City and shall be in effect on and after the date following such publication.
